On behalf of the City of Lake Elsinore, I am writing to strongly support Elsinore Valley Municipal Water District's (EVMWD) Community Project Funding application for the Canyon Lake Water Treatment Plant, (CLWTP) Phase 2 PFAS Treatment. As our state experiences historic drought along with significant population growth, projects like the CLWTP will contribute to local water supply security and help offset demands on the already stressed imported water supplies.

We rely on EVMWD to provide water to our community and with growth in the region projected to increase nearly 50 percent over the next 25 years, water consumption will place a greater demand on EVMWD's system.

The CLWTP is an integral part of EVMWD's local water supply portfolio and is a conventional water treatment facility using mixed media filtration. The plant is rated at 9 million gallons per day (MGD) capacity; however, the UV Treatment is rated at 7 MGD and due to operational constraints, production currently averages between 3 to 5 MGD.

Within the last year and a half, per- and polyfluoroalkyl substances (PFAS) at elevated levels in water quality sampling of Canyon Lake were detected. Canyon Lake has recently exceeded state Notification Levels for both PFAS and PFOA and exceeded the Response Level for PFOA. As a result, the treatment plant has been off-line since November 15, 2019 until a treatment solution can be found to reduce these levels.

Phase two of the CLWTP facility will treat for contaminants like per- and polyfluoroalkyl substances (PFAS) and be able to support population growth throughout the region. These improvements will produce an increased supply of safe, high-quality water, and reduce dependence on imported drinking water. This type of proactive planning and action is key to ensuring water availability for the future of the service area.

The proposed improvements to the CLWTP will sustain local growth and improve the quality of water treatment and operations. This project will benefit the region's residents and businesses now and into the future.


