Rep. Calvert Opposes These and All Tax Increases

Schedule of Looming Income Tax Increases:

Effective January 1, 2011

■ Higher income tax rates:

- Increase the 10% tax bracket to 15%
- Increase the 25% tax bracket to 28%
- Increase the 28% tax bracket to 31%
- Increase the 33% tax bracket to 36%
- Increase the 35% tax bracket to 39.6%

■ Reinstate the "marriage penalty" tax

■ Cut the child tax credit in half (from \$1,000 to \$500)

■ Higher investment taxes:

- Increase top rate on long-term capital gains tax from 15% to 20%
- Increase top rate on qualified dividends from 15% to 39.6%

■ Resurrection of the Death Tax: currently repealed, will rise to rates as high as 55%

TOTAL COST TO AMERICAN FAMILIES = \$200 BILLION in 2011 and \$3.8 TRILLION over 10 Years
