# SOCIAL SECURITY REFORM ACT

On April 2, 2003, the House of Representatives approved H.R. 743, the Social Security Act of 2003, which strengthens Social Security by helping extinguish known fraud and abuse. The legislation includes the following provisions:

- Raises the standards and imposes stricter penalties for exploitive representative payees who were meant to help manage the affairs of seniors and individuals with disabilities
- Halts payments to fugitive felons and parole/probation violators
- Helps people with disabilities gain access to legal representation when applying for Social Security benefits
- Reforms a loophole in the Government Pension Offset that the nonpartisan Government Accounting Office reported so far could cost the trust fund nearly \$450 million

The bill was referred to the Senate on April 3, 2003, but the Senate has yet to take any action. Part of ensuring the long-term solvency of Social Security is rooting out fraud and waste within the program. I encourage you to contact both California Senators in support of this legislation so that we can continue to preserve and protect Social Security.

# MEDICARE REFORM

Medicare has provided countless seniors with the care they need and deserve. As we move into the 21st Century we need to ensure that these needs continue to be met. Congress has a responsibility to modernize Medicare so that seniors may continue to live longer, healthier lives. The main principles of the House Republican plan currently in conference include:

### Principle 1: Guarantee All Senior Citizens an Affordable Prescription Drug Benefit Under Medicare

- Allow all seniors to voluntarily participate in a Medicare plan that provides prescription drug coverage and leverages the purchasing power of seniors to negotiate discounts
- Help seniors immediately lower their prescription drug costs
- Provide additional assistance for low-income seniors who need the most help to improve their quality of life

### Principle 2: Protect Senior Citizens with the Right-to-Choose a Benefits Package that is Best for Them

- Provide seniors with a better range of plan options under Medicare
- Cap out-of-pocket costs so seniors will not risk bankruptcy in case of serious illness

### Principle 3: Strengthen Medicare for All Senior Citizens and Future Generations

- Ensure delivery of needed health care services in rural and urban America
- Create structural improvements to curb runaway health care costs that jeopardize Medicare's financial future
