RE: Support for the City of Lake Elsinore's Project Request

Dear Representative Calvert:

We are writing in support of the City of Lake Elsinore's community project funding requests for FY2024. The following four projects will positively benefit the community and its citizens. More importantly, they align with the City's long-term strategic plan, Dream Extreme 2040 Plan, and our vision to become the ultimate lake destination where all can live, work, and play, build futures and fulfill dreams.

Water Quality Project

Lake Elsinore is home to Southern California's largest natural freshwater lake. The recreational lake is situated at the end of the 780 square mile San Jacinto Watershed, Lake Elsinore is reliant on rainfall and watershed runoff. With the runoff water also comes sedimentation that can harm the ecology and water quality of the lake. Lake Elsinore is vulnerable to fish die offs and algal blooms. Every day, five million gallons of highly treated recycled water from Elsinore Valley Municipal Water District's Regional Water Reclamation Facility is added to Lake Elsinore. This water is used to offset evaporation.

The Lake Elsinore and San Jacinto Watersheds authority has worked hard over the years to improve water quality. Through the partnership between regional partners and its supporting agencies, Lake Elsinore has received support through fishery studies, carp removal, pump station improvements, bass stocking, destratification, recycled water delivery and habitat enhancements.

Lake Elsinore has historically been vulnerable to algae blooms; Algae blooms occur when the algae grow at rapid speeds than normal causing dense accumulations in the water. They can become harmful when there is excessive growth. Lake Elsinore was recently closed to the public for six months due to high levels of cyanotoxins that are dangerous to the public health. The city along with its regional partners are exploring new technology to improve the water quality of the lake.

Homeless Facility Expansion

In December 2021, the city opened the Anchor, a crisis stabilization housing complex owned by the City of Lake Elsinore and operated by Social Work Action Group (SWAG) serving chronic homeless individuals from Lake Elsinore, Wildomar and adjacent county areas. The Anchor has 14 separate units and can house up to 20 individuals. Each individual is selected and placed by the City's Homeless Task Force for up to 90 days and must be thoroughly assessed prior to placement.

The City believes it has created a model approach to developing a comprehensive program that addresses homelessness by leveraging funds, resources, partnerships, and the community to create innovative and effective solutions.

The next phase of the City's approach to meet our goal of reaching functional zero in terms of chronic homelessness by 2025 is tackling our local encampments. The city is concerned with encampments along State Route 74 which cuts through the North side of Lake Elsinore and is adjacent to the Lake. It is estimated that 40 - 50 homeless individuals reside in this area. During the summer months this number is believed to increase to 50-60 due to the vegetation cover and access to the Lake.

The encampments in this area tend to be fully developed camp sites with multiple structures and tents. Most homeless are scattered throughout the vegetation and are connected by manmade pathways. When lake levels increase during the winter, some of the areas flood and cause garbage and human waste to flow into the lake. Homeless individuals create small campfires for cooking and to provide heat causing a high risk for wildfire. Our CALFIRE partners have responded to 1,490 calls for service in these areas in the last five years including small fires in and near these encampments, not only threatening residents and businesses in the area, but also State Route 74.

The City of Lake Elsinore has had great success with our first homeless facility the Anchor and we are looking to open a new facility to house 60 residents in a combination of 20 studios and 40 cubicle style bedrooms. The facility will have supportive services, resident storage, animal areas and services, and indoor and outdoor spaces. Many of the residents living in the encampments have resisted current services because the lack of personal storage or not being able to bring their animals. This new facility will be low barrier housing with a clear pathway to permanent supportive housing.

- City Contribution: \$500,000

Camino Del Norte Infrastructure Improvements

In February 2021, the City of Lake Elsinore opened its newest roadway – Camino Del Norte. This nearly one-mile-long roadway opened more than 125 acres of prime commercially zoned land for future development along Interstate 15. In addition, it greatly improved circulation in the eastern part of the city and provides an alternative roadway for traffic along the freeway. The area surrounding Camino Del Norte is largely undeveloped and requires significant infrastructure for any future developments. Therefore, the city is seeking funding for this economic development catalyst project to install infrastructure along the roadway that includes

the installation of water, sewer, electrical, gas and broadband. In addition, if funding allows, the city will include lighting and pedestrian improvements.

Camino Del Norte is designated a major roadway and will increase from two-lanes to four-lanes in the future. This project will be constructed alongside the existing roadway, which will allow the project to be swiftly completed. This project aligns with serving as an economic development initiative by opening prime development opportunities in Southern California's second fastest growing City (according to 2020 Census).

- Federal Funding Sought: \$2 million
- City Contribution: \$500,000

Lakepoint Park & Senior Center Improvements

This park needs new playground equipment, lighting, and artificial turf including circulation improvements. The city is requesting \$2.5 million for the improvements.

The City of Lake Elsinore has 20 community parks. One of its oldest and only lakefront parks is Lakepoint Park. This picturesque park offers two (2) softball fields, a soccer/football field, playground, walking paths (0.36 mile), concession stands and restrooms. In addition, the park offers shaded picnic facilities, barbeque areas and a wonderful view of Lake Elsinore and the Ortega Mountain Range. This park currently serves as the primary location for youth football leagues in the city.

This project proposes the complete restoration of all sport fields including a large artificial turf field with multiple sport line/overlays to accommodate all sports, baseball/softball, football, soccer, lacrosse, etc. Additional proposed improvements include improving connectivity and access to the lake, new playground equipment that aligns with the park's lakefront appeal, restroom upgrades and new snack bar facilities.

- Federal Funding Sought: \$2.5 million
- City Contribution: \$500,000

We strongly support each of these projects. We look forward to your support for the continued growth and development within the City of Lake Elsinore.
