Dear Representative Calvert,

I am writing in support of the City of Corona's request for several Community Funded Project submissions for Fiscal Year 2025.

The City's top priority request is for \$4,000,000 from the Fiscal Year 2026 Transportation and Housing and Urban Development Appropriations bill, Highway Infrastructure Programs account to widen Magnolia Avenue from El Camino Avenue to Leeson Lane, as well as the bridge over the Temescal Wash, to increase travel lanes from four to six, install new ADA-compliant sidewalks, Class II bike lanes, raised medians, and traffic signals throughout the project scope.


The completion of the project will expand the existing roadway and bridge to accommodate projected travel demands and provide safe and accessible facilities for pedestrians and bicyclists between communities. The proposed improvements will also relieve a critical passenger and goods movement bottleneck, improve traffic flow from East Sixth Street and the Interstate 15 freeway ramps, and enhance pedestrian and bicycle safety and mobility by eliminating the existing missing sidewalk gaps. The project will enable increased mobility and reduced congestion through this pinched area of the roadway and promote the swift movement of goods for industrial and commercial uses.

The City's second request is for \$1.7 million from the Fiscal Year 2026 Transportation and Housing and Urban Development Appropriations bill, Economic Development Initiative account for the City's Trails Improvement Project. This funding will allow the City to make a variety of trailhead improvements and provide amenities that will allow more pedestrian and bike opportunities, preserve and improve trail access, close gaps in the City's trail system, connect residents with nature, promote active transportation, and increase the physical activity and health of residents of all abilities through increased accessibility to open spaces.

The projects funded by this request will improve connectivity to internal and regional trails outside the City and improve connectivity to schools, parks, neighborhoods, open space, downtown, and the Cleveland National Forest. These trails will connect disadvantaged communities to the Cleveland National Forest, commercial properties, schools, businesses and industrial uses, parks, and the two Metrolink Rail Commuter stations located within Corona, providing safe, equitable access to jobs,

education, healthcare, and food. The trails within the City of Corona are fundamental in improving active transportation, reducing greenhouse emissions, and increasing community health, safety, and cohesion.
